We further wish to inform that based on scrutinizer's report, the resolution set out in the notice of the Postal Ballot has been duly approved by the shareholders with requisite majority.

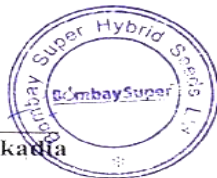

Mr. Arvindkumar Kakadia , Managing Director of the Company , duly authorized for the purpose of declaring the Postal Ballot Result stated in Postal ballot Notice dated Monday, March 22,2021. , The Board of Directors of the Company, at their meeting held on Monday, March 22,2021, appointed Mr. Vijay Anadkat, Company Secretary in Practice (CP No. 12051), as the Scrutinizer for conducting the postal ballot/e-voting process in fair and transparent manner. The Scrutinizer has submitted their report to the Chairman of the Company after the completion of the scrutiny of the E voting. The results was declared on Saturday, April 24, 2021 at the Registered Office of the Company in presence of Chairman.

pursuant to Section 110 of the Companies Act, 2013, as amended (hereinafter referred to as the “Act”) read together with Rule 22 of the Companies (Management and Administration) Rules, 2014, (including any statutory modification(s) or re-enactment(s) thereof for the time being in force), General Circular No. 17/2020 dated April 13, 2020 issued by Ministry of Corporate Affairs, Government of India and pursuant to other applicable laws and regulations, Chairman has placed the record of Compliances made in provision with requisite Regulations of the Act.

- (1) The Board of Directors of the Company, at their meeting held on Monday, March 22,2021, appointed Mr. Vijay Anadkat, Company Secretary in Practice (CP No. 12051), as the Scrutinizer for conducting the postal ballot/e-voting process
- (2) The voting period was commenced on Thursday, March 25, 2021 at 9 a.m. **(9.00 hours IST)** and concluded on the Friday, April 23, 2021 at 5.00 p.m. **(17:00 hours IST)**. During this period members of the company, holding shares as on the cut-off date i.e. Friday, March 19,2021 , were allowed to cast their vote electronically. The e-voting module was disabled by CDSL for voting thereafter.
- (3) The Company has announced The dispatch of Postal Ballot Notice through an advertisement in at least 1 (one) English newspaper and at least 1(one) in Gujarati newspaper, each having wide circulation in the State of Gujarat, where the registered office of the Company is situated.

SCRUTINIZER'S REPORT ON THE POSTAL BALLOT PROCESS CONDUCTED THROUGH REMOTE E-VOTING

Dear Sir,

I, Vijay B. Anadkat, Proprietor of M/s. Vijay Anadkat & Associates, Practicing Company Secretaries, was appointed as Scrutinizer by the Board of Directors of **Bombay Super Hybrid Seeds Limited** for scrutinizing postal ballot which was conducted only through electronic means in respect of the resolutions contained in the Notice dated March 22nd, 2021 in a fair and transparent manner and for ascertaining the requisite majority for the resolutions proposed to be passed with respect to the provisions of Section 110 of the Companies Act, 2013 ('the Act') read with Rule 22(1) of the Companies (Management and Administration) Rules, 2014 (as amended) and in terms of the General Circular No. 17/2020 dated 13th April, 2020 and General Circular No. 39/2020 dated 31st December, 2020 (the "MCA Circulars"), issued by the Ministry of Corporate Affairs, Government of India (the "MCA,") and Regulation 44 of Securities and Exchange Board of India (Listing Obligations & Disclosure Requirements) Regulations, 2015, as amended, ["SEBI Listing Regulations"] on the resolutions as set-out in the notice of Postal Ballot.

I submit my report as under:

- 1) The Management of the Company is responsible to ensure the compliance with the requirements of the Act, and Rules made thereunder including MCA Circulars issued by the MCA in view of the current extraordinary circumstances due to **COVID - 19** pandemic requiring social distancing, have advised the companies to take all decisions requiring members' approval, other than items of ordinary business or business where any person has a right to be heard, through the mechanism of postal ballot/e-voting in accordance with the provisions of the Companies Act 2013 and rules made thereunder, without holding a general meeting that requires physical presence of members at a common venue and SEBI Listing Regulation, relating to postal ballot process conducted through electronic means.
- 2) The Company has availed the e-voting facility offered by Central Depository Services (INDIA) Limited (CDSL) for conducting remote e-voting by the shareholders of the Company and it has provided a system for recording the votes of the shareholders electronically.



- 3) My responsibility as **Scrutinizer** is restricted to make **Scrutinizers' Report** of the votes cast "For" or "Against" the resolutions stated in the Notice of Postal Ballot.
- 4) Pursuant to the MCA Circulars the Members of the Company holding equity shares, as on the "cut-off date" i.e., Friday, March 19th, 2021 were entitled to vote on the proposed resolutions as set out in the Notice of Postal Ballot dated March 22nd, 2021, through remote e- voting only.
- 5) The remote e-voting period commenced from Thursday, March 25th, 2021 (09.00 A.M.) and ended on Friday, April 23rd, 2021 (5.00 P.M.) at the e-voting Platform on the designated website of by Central Depository Services (INDIA) Limited (CDSL) i.e. ([http://www. https://www.evotingindia.com](http://www.evotingindia.com)). E-voting facility was blocked thereafter.
- 6) Pursuant to the provisions of the Act and MCA Circulars issued by Ministry of Corporate Affairs, the Company has sent Postal Ballot notice(s) to its Members whose name(s) appeared in the Register of Members/ List of beneficial owners received from Central Depository Services (India) Limited as on the Cut-off date i.e. Friday, March 19th, 2021 and whose e-mail IDs was available with the Company and Depositories, through electronic means only and has not dispatched physical notices to any member. Further the Company vide the Postal Ballot notice dated March 22nd, 2021, had also requested its shareholders to register their email addresses with the Registrar and Transfer Agent of the Company.
- 7) As stated in Sub-rule 3 of Rule 22 of Companies (Management and Administration) Rules, 2014 as amended from time to time & MCA circulars, on Wednesday, March 24, 2021, public notices were published by the Company in Financial Express ('English Newspaper') and in Sanj Samachar ('Gujarati Newspaper') informing about the completion of dispatch of Postal Ballot notices to its shareholders through electronic means, along with all requisite document.
- 8) I monitored the process of electronic voting (i.e., remote e-voting) through the scrutinizer's secured link provided by Central Depository Services (INDIA) Limited (CDSL) through its designated website.
- 9) After completion of e voting, votes casted by the members, were unblocked by me in the presence of two witnesses, Mr. Yashraj H. Pancholi & Mr. Ravi P. Lakhwani who are not in the employment of the Company.
- 10) The remote e-voting report downloaded from the website of CDSL have been kept separately for the purpose of postal ballot.



- 11) Votes casted by the members through remote e-voting, were reconciled with the records maintained by the Registrar and Transfer Agent of the Company and authorizations lodged with the Company.
- 12) The Postal Ballots and other related documents/registers and record will be handed over to the Company Secretary for the safe custody once the Chairman consider, approve and sign the Postal Ballot Minutes.
- 13) After ascertaining the votes casted by remote e-voting, I hereby submit the result as under:
